How do I buy, sell or switch funds, and which forms do I need?

Investment Centre funds

To instruct a buy, sell or switch trade for funds held via the Investment Centre, you should use our free and secure online service, James Hay Online. You can also use the Investment Centre Buy, Sell or Switch forms available on our website, however paper instructions will incur a charge in accordance with the charges schedule for your product.

Funds not available on the Investment Centre

You will need to complete our Instruction to Trade Form and send this to us.

If it is the first time you have invested with a particular fund provider, you will also need to send us their application form with all mandatory fields completed on it.

For additional investments, switches or sales, our Instruction to Trade Form is normally sufficient although some fund providers may insist on their own forms being completed and if so, you will need to send these to us as well.

How do I appoint an investment manager or stockbroker?

A list of investment managers/stockbrokers who have an agreement with us can be viewed on our website. The appointed investment manager/stockbroker must be UK based and regulated by the Financial Conduct Authority (FCA).

You should then complete the Investment Manager Appointment Form and send this to us along with the investment manager's/ stockbroker's account opening paperwork that we will need to complete as trustee of your plan.

You will need to discuss any investment strategy with your investment manager/stockbroker, including whether they will be acting on an execution-only, advisory or discretionary basis. You will need to review and agree to their terms and conditions and charges.

Once you've decided which deposit account on our cash panel you wish to use, you should complete the application form and send it to us.


Property
